



FRIENDS OF WYE MARSH WEBSITE USAGE AGREEMENT & LEGAL NOTICES

Wye Marsh is the operating name for the Friends of Wye Marsh, an incorporated registered charitable organization. The following terms of use apply to any visitor or user (hereinafter referred to as "User" or "You") of the website www.wyemarsh.com and any websites that are hyperlinked to and from the website www.wyemarsh.com (hereinafter singularly and collectively referred to as "the Site") that Friends of Wye Marsh (hereinafter singularly and collectively referred to as "Wye Marsh") own and control, and to the products, services, resources, information, data, specifications, photographs, text, audio, video and other content displayed on the Site ("Material").
